- 1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 2. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total OUANTITY.
- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 60% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

# **Buyer Added Bid Specific Terms and Conditions**

#### 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1.(a)Bid total estimated value is Rs 2,63800/- only in which 150,000 is reserved for Atal Tinkering Lab Laptop and Projector as per ATL,AIM GUIDELINE AND SPECIFICATION and rest of the amount reserved for 60 students ATL lab setup furniture with teacher table and chair and instruments and equipment tool boxes as well as LAB refurbishment work and poster,banner and flex printing and final touch of ATL lab as per ATL,AIM Guidelines .

- (b) All seller/vendors can inspect the location on provided date for furniture placing and layouts of plan for furniture setup and electrical fittings and power supply provision and power supply extension work for instruments and equipments as well as Lab refurbishment work and banner ,flex and poster fixing area .
- (c) No any exta amount will be provided for any work beyond this amount and all above said works have to complete with in this amount.
- (d) All specifications of items with quantity (Furnitures ,Laptop and projectors) must be provided with the bid documents with layouts,specification diagram of furnitures,teacher table and chair,students table and sitting chairs,tool boxes and banners etc.
- (e) Photographs and Video or their links must be provided by seller where they earlier settled the ATAL TINKERING LAB or equivalent lab. Also provide their previous work experience location to verify their work performance .

- 2. The products will be verified at the Consignee's location before the final acceptance of Goods. If anything is found defective or not according to the specifications, then the seller will have to replace the item within the given time limit. The Payment will be released based on the final acceptance report of the Buyer. The payment will only be released after the successful delivery of final accepted Goods
- 3. The Transportation and Installation cost will be borne by the seller. The seller can not ask for the Additional payment at the time of delivery or installation. The items not according to the requirements will be returned to the seller and the seller will have to replace that item within the given time limit.
- 4. The seller will have to share the previous orders of similar work in the given region for the last 3 years. The Bidder should have to share the Order Completion Reports through Government e-Marketplace for Eligibility of Commercial Eligibility. The Bidder will be Rejected if they fail to share the same in the Participating documents. If the Orders are found to be incorrect or fraudulent, that seller will be Disqualified and further requests will not be entertained. All the Documents related to Experience Criteria, Offering, Turnover, Authorization Certificate and any other certificates will have to be submitted with the ATC Documents. If the seller fails to upload any documents in the ATC section, they will be rejected with immediate effect without further entertainment.
- 5. All equipment /components Educational poster, specification sheet and their safely up keeping arrangement(Box, Equipment casings, drowers etc) should be provided by supplier for safe regular use.

- 6. The Seller should have a Local Presence for bid Participation. A copy of Rent Agreement/Registration Document/ Electricity Bill etc. to be shared along with the bid.
- 7. The Bidder should have supplied similar kinds of items in the Location in the past year. The 10-15 Order copy will have to be shared by the Bidder. The Bidder should have supplied and completed similar work in the State in the past two years, 25-30 order copies of which is to be shared by the bidder. The order copies from the past 3 years are required. The order copies of Kendriya Vidyalaya's will be preferred.
- 8. All the Certifications like ISO, MSME, Brand Registration, Bank mandate Format, Cancelled Cheque, GSTIN, PAN and Vendor Assessment Report of the latest year should have to be attached with the letter.
- 9. The bidder will have to accept the Terms and Conditions mentioned in the Additional Terms & Conditions Section. Any bidder who fails to declare the same will be rejected without any further entertainment.
- 10. The bidder should have its operational office in the region for proper service of the offered product. 10. The OEM of the Offered item will be preferred over Reseller.
- 11.If any product/item found unsatisfactory and vendor/seller not providing the item with in time limit ,then maximum GeM price of that item will be deducted .
- 12. Performance security is mandatory as per bid document.
- 13. Bid may be cancelled before providing supply order to L1 without giving any reason ,it is totally depending upon ATL committee KV Hazaribagh.
- 14.Bidder may be technically disqualify if any defaulter case found in any Kendriya Vidyalaya /Govt.Agency or any bad record fond on GeM report/incident raised.
- 15.Bid may be cancelled any time without providing any reason if any instruction came from competent authorities .
- 16. All terms and conditions of ATL,AIM,GOVT. OF INDIA are applicable.
- 17. Quantity of the same items in the bid may be increase for other purposes with in offer validity.

# Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents / clauses shall also be null and void. If any seller has any objection / grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is also governed by the General Terms and Conditions

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
